#### **Guidelines:**

#### Girl Scouts' World of Girls Birthday Bash.

2012 is an event produced by Girl Scouts of Southern Nevada. All activities, sponsors and vendors agree to abide by the following guidelines:

- Girl Scouts of Southern Nevada reserves the right to select exhibitors on the basis of appropriateness of the product, or service, product mix, product display and committee review. Additionally, all vendors must align with the mission and values of Girl Scouts.
- 2. Girl Scouts of Southern Nevada is the sole judge of the above and makes all assignments of space.
- 3. No tobacco, alcohol, illegal narcotic products, or weapons of any kind will be allowed at the event.
- 4. More than 2,000 people are expected to attend **World of Girls**. If the samples are to be distributed, vendor agrees to provide an adequate amount. At minimum, vendor must stagger sample distribution to planned interval throughout the event.
- 5. Exhibitors may check in between 7-8 a.m. on the day of the event. If you are not checked in by 9 a.m., Girl Scouts may reassign your area. All booths are expected to be fully set up by 8:30 a.m.
- 6. Event hours are 9 a.m.-2 p.m. We require booths to be adequately staffed the entire time.
- 7. Vendors cannot collect any girl information; only adults may provide their contact information.
- 8. Completed applications must be received and approved for any discounts to be applied.
- 9. Vendors can apply to become a Program Partner and receive a partner discount; application to become a Program Partner must be submitted with Vendor Application.
- 10. Upon review of application, some vendors may be required to provide Girl Scouts of Southern Nevada with a certificate of insurance.
- 11. We do not offer exclusives to vendors.
